The Correspondent has submitted the application for Renewal of Recognition for Classes I to VII in the SCHOOL for the years from 2023-24 to 2025-26 in the letter reference 4th cited. The Mandal Educational Officer, Nallajerla has verified the application for Renewal of Recognition with reference to the conditions laid down in the permission orders and G.O.Ms.No.1 Edn. Dept. dated 01-01-1994, G.O.Ms.No.41 Edn. Dept. dated 11-05-2006 and G.O.Ms.No.74 Edn. Dept. dated 11-09-2006 and recommended to accord Renewal of Recognition from 2023-24 to 2025-2026. The District Educational Officer, East Godavari, Rajamahendravaram hereby accords Renewal of Recognition for a period of Three (03) years commencing from the academic year from 2023-24 to 2025-2026 for cases I to VII (English Medium) subject to the fulfillment of the following conditions in respect of BETHESDA UPPER PRIMARY SCHOOL(E.M),Prakasaraopalem, Nallajerla Mandal,East Godavari, Rajamahendravaram without Grant In Aid now or in future.

1. That the society shall abide by the instructions or rules and regulations made by the government or authorized officer from time to time
2. That the educational institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed by government from time to time.
4. That the SCHOOL timings, vacations and mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by the Government employees shall be appointed as per the staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure or fee structure fixed by the governing body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.s and other orders which are not

specified in this order shall be complied with.

11. That the School shall not be closed without giving notice both to the parents, District Educational Officer and competent authority at least six months before.
12. That the School shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposals for renewal of recognition sufficiently in advanced (i.e) at least six months prior to the date of the present recognition.
14. All the appointments should be regulated as per norms stipulated in G.O.Ms.No.1 Edn. Dept. dated 01-01-1994.
15. Other conditions as per G.O.Ms.No.1 Edn. Dept. dated 01-01-1994, G.O.Ms.No.41 Edn. Dept. dated 11-05-2006 and G.O.Ms.No.74 Edn. Dept. dated 11-09-2006 should be followed from time to time.
16. Economic strength should be maintained for all classes.
17. Structural Soundness and Sanitary Certificates issued by the competent authority should be produced every year.
18. NOC issued by the District Fire Officer should be produced a fresh after expiring of the Certificate, if applicable.

The Correspondent is hereby informed that the District Educational Officer, East Godavari, Rajamahendravaram has vested powers to with draw the recognition now accorded if there is any deviation furnishing false information & non fulfillment of conditions as per rules in force without any notice in future.



In the reference 2nd read above, the Government of A.P have enhance the recognition period from (3) years to (8) years, duly amending the Andhra Pradesh Right of Children to Free and Compulsory Education Rules, 2010, issued in G.O.Ms.No.20, School Education (PE-Prog.I) Department, dated 03.03.2011 and inserting certain gudlines after clause (1) in Sub rule (4) of Rule 14 of the said G.O and the same was communicated by the Commissioner of School Education, AP, Amaravati in the reference 3rd read above.

In the reference 4th read above, the Government of AP have accorded permission to extend the recognition of the schools from 03 to 08 years those who have already taken recognition for a period of 03 years, to comply the orders dated 11.08.2023 of the Hon'ble High Court in W.P.No.18190 of 2023 and the same was communicated by the Commissioner of School Education, AP, Amaravati with a request to take necessary action accordingly in the reference 5th read above.

Previously, renewal of recognition has been accorded to Bethesda Upper Primary EM School, Prakasaraopalem, Nallajerla Mandal for the classes I to VII for 03 years from 2023-24 to 2025-26 in the reference 1st read above.

In the reference 8th read above, the Mandal Educational Officer, Nallajerla has submitted, the representation of Correspondent, Bethesda Upper Primary EM School, Prakasaraopalem, Nallajerla Mandal and recommended to accord extension of renewal of recognition for the remaining period of 05 years which was accorded by this office in the reference 1st read above.

In view of the recommendation of the Mandal Educational Officer Nallajerla in the reference 8th read above and provisions laid down in GO.Ms.No.38 SE(Prog.II) Dept., dated 22.04.2023, G.O.Ms.No.90 SE(PS) Dept., dated 17.11.2023 and as per the instructions issued by the Commissioner of School Education, AP, Amaravati in the references 3rd, 5th and 6th read above, the recognition granted by this office in the reference 1 read above to the classes I to V is hereby extended for remaining **05 (FIVE)** years i.e., from 2026-27 to 2030-31.
